

## **“The Mighty 4WD Giveaway” Competition Terms and Conditions**

### **Terms and Conditions**

1. Entry into the Australian Military Bank “The Mighty 4WD Giveaway” competition is governed by these terms and conditions.
2. Entering this Competition is deemed acceptance of these terms and conditions.

### **Competition and permit details**

3. Australian Military Bank Ltd is the Promoter, ABN 48 087 649 741, Australian credit licence 237 988, AFSL 237 988, with registered office in Level 1, 1 Bligh Street, Sydney, NSW 2000 / Telephone 1300 13 23 28 (“Promoter”).
4. This promotion is authorised under ACT Permit No. ACT TP 24/03052, SA Permit T24/2298, and NSW Authority No. TP/04042.
5. This competition shall be governed by the laws of New South Wales, Australia and the legislation applying to promotions of this type in each State and Territory in which it is conducted.
6. This competition is in no way sponsored, endorsed or administered by, or associated with Facebook or Instagram.

### **Competition period**

7. Entries into the promotion open at 09:00am AEDT on 28 January 2025 and close at 11:59pm AEST on 01 May 2025 (“Promotional Period”), based on times applicable in NSW.

### **Prizes**

8. The major prize is a vehicle valued at \$65,000. The prize value will be deposited into the winner’s Australian Military Bank account to purchase the vehicle of their choice at their local dealership.
9. There are 12 minor prizes of BP fuel vouchers valued at \$500 each. Fuel vouchers will be emailed or mailed to the winners.
10. The total prize pool for the entire promotion is \$71,000.
11. The prize offered is not transferrable or exchangeable.

### **Eligibility to enter**

12. Entry is only open to Australian Military Bank members aged over 18 years of age (“Eligible Entrants”).
13. Employees and Directors of the Promoter (or any of its related entities) and their immediate families are ineligible to enter the competition.

### **How to enter**

14. To receive one entry into the draw, Eligible Entrants must have at least one regular salary, pension or superannuation deposit from an eligible employer or pension/superannuation provider, detailed in clause 16, into one of the following Australian Military Bank accounts:

  - ▶ 100% Mortgage Offset Account
  - ▶ Pension Access Account.
15. The salary, pension or superannuation deposit must be made by the draw period end date in the Draw Schedule detailed in clause 20.

17. There is a limit of one (1) entry per account. You do not receive multiple entries for joint account holders or based on the number of salary deposits during the Promotional Period.
18. Competition entry is automatic based on meeting the entry criteria above.
19. If an Eligible Entrant does not want to be entered into the competition, they can contact Australian Military Bank on 1300 13 23 28 to be excluded.

### Drawing winners

22. Eligible entrants are limited to one (1) minor prize for the Promotion and the major prize.

### Notification of winners

23. The winners will be notified by the Promoter by email and telephone within three (3) business days of the draw.
24. Their last name, first initial and postcode will be published on the Australian Military Bank website within thirty (30) days of the relevant draw.
25. The winner's first name and last name initial may also be published on the Australian Military Bank social media pages.

### Accepting and receiving the prize

26. Winners must confirm their acceptance of the prize within 3 weeks of the draw.
27. Major Prize winner – \$65,000 cash prize will be deposited into the winner's Australian Military Bank account to purchase the vehicle of their choice at their local dealership within 3 weeks of the relevant winners' acceptance and verification. At the time of acceptance, verification will include confirmation of:
- ▶ their Australian Military Bank membership number,
  - ▶ their membership is active;
  - ▶ and their eligible account is open
  - ▶ one eligible salary, pension or superannuation deposit has been received in the draw period.
28. Minor Prize winners – \$500 BP fuel vouchers will be emailed or mailed to the prize winners within 3 weeks of the relevant winners' acceptance and verification. At the time of acceptance, verification will include confirmation of:
- ▶ their Australian Military Bank membership number,



- ▶ their membership is active; and
  - ▶ their eligible account is open
  - ▶ one eligible salary, pension or superannuation deposit has been received in the draw period.
29. The Promoter is not responsible for the manner in which the prize money is utilised and does not accept liability for any expenses incurred by a winner in redeeming the prize including any tax implications.
30. The Promoter is not responsible for any additional costs associated with on-road and/or delivery costs.

### Right to redraw

### Entry details and privacy

33. ### Limitation of liability and variation of terms

35. Australian Military Bank's decision is final and no correspondence will be entered into.
36. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

- ▶ any theft, unauthorised access or third party interference;
- ▶ any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by Australian Military Bank) due to any reason beyond the reasonable control of Australian Military Bank;
